**AMENDED ADMINISTRATIVE ORDER GOVERNING COURT-ANNEXED
NON-BINDING ARBITRATION**

WHEREAS, Florida Rule of Civil Procedure 1.810 requires that the Chief Judge of each judicial circuit or the Chief Judge’s designee maintain a list of qualified persons who have agreed to serve as arbitrators in civil cases; and

WHEREAS, these statutes and rules provide for the establishment of a court-annexed non-binding program to which civil cases can be referred by these courts and per Administrative Order No. 07-91-27, the Orange County Bar Association Arbitration Service was designated as a court-annexed program to maintain a list of qualified persons to serve as arbitrators in civil cases in Orange County; and

WHEREAS, the Orange County Bar Association Arbitration Service now no longer provides these services making it now necessary that an updated list of arbitrators be established by this Circuit;

NOW, THEREFORE, I, Belvin Perry, Jr., pursuant to the authority vested in me as Chief Judge of the Ninth Judicial Circuit of Florida under Florida Rule of Judicial Administration 2.050 order as follows:

1. The named persons in Attachment “A” to this Order are eligible to serve as arbitrators in civil cases, with the exception of cases as stated in Florida Rule of Civil Procedure 1.800 and medical malpractice and related cases which are governed by section 766.107, Florida

Statutes and by separate Administrative Order.

2. The Dispute Resolution Services Office under Court Administration in Orange County and the Mediation Program under Court Administration in Osceola County shall maintain an updated list of the qualified arbitrators and shall distribute the list of arbitrators to the Judges of the Ninth Judicial Circuit and to any other interested persons upon request and may supplement the list with additional qualified persons upon approval by the Chief Judge, but without the necessity of a subsequent Administrative Order.

3. Pursuant to section 44.103, Florida Statutes, the arbitrators are to be compensated by the parties in an amount not to exceed \$200 per day, unless otherwise agreed to by the parties and approved by the Court.

4. This Administrative Order is effective immediately and Administrative Order No. 07-91-27 dated February 21, 1992 is vacated and set aside.
