**ADMINISTRATIVE ORDER IMPLEMENTING A STANDARD
TOBACCO CITATION FORM IN ORANGE COUNTY**

WHEREAS, sections 386.212, 569.11 (1) & (2) and 569.005, Florida Statutes address violations involving smoking by minors on or near school property; possession of tobacco by minors; misrepresentation of age by minors when attempting to acquire tobacco products; and violations for operating a retail business selling tobacco products or operating a tobacco products vending machine without a retail tobacco products dealer permit; and

WHEREAS, implementation of a standard citation form for the violations stated above will provide for the efficient issuance and processing of citations for such violations;

NOW, THEREFORE, I, Ted Coleman, pursuant to the authority vested in me as Chief Judge of the Ninth Judicial Circuit of the State of Florida under Florida Rule of Judicial Administration 2.050 order the following:

Effective **October 4, 2000**, when issuing citations for violations under sections 386.212, 569.11 (1) & (2) and 569.005, Florida Statutes, the attached standard tobacco citation form shall be implemented and utilized by all law enforcement agencies including the Orange County Sheriff's Office; each city police department in Orange County; the Florida Highway Patrol; the University of Central Florida Police Department; and the Division of Alcoholic Beverages and Tobacco.
