**ADMINISTRATIVE ORDER RECALLING CERTAIN ACTIVE DEPARTMENT OF
REVENUE CHILD SUPPORT WRITS ISSUED BETWEEN JANUARY 1, 1999,
TO THE PRESENT, ORANGE COUNTY**

WHEREAS, pursuant to Article V, section 2(d) of the Florida Constitution and section 43.26, Florida Statutes, the chief judge of each judicial circuit is charged with the authority and the power to do everything necessary to promote the prompt and efficient administration of justice; and

WHEREAS, to create and maintain an organization capable of effecting the efficient, prompt, and proper administration of justice for the citizens of this State, the chief judge is required to exercise direction, *see* Fla. R. Jud. Admin. 2.215(b)(2), (b)(3); and

WHEREAS, by Administrative Order dated February 27, 1998, the Supreme Court of Florida ordered that, pursuant to Florida Family Law Rule of Procedure 12.491, hearing officers may be utilized in this Circuit to consider proceedings for the enforcement of support in both Title IV-D and non-Title IV-D cases; and

WHEREAS, by Administrative Order No. 07-95-44, the Chief Judge has implemented the provisions of rule 12.491 in the Ninth Judicial Circuit; and

WHEREAS, there exists approximately 515 outstanding active Department of Revenue (DOR) Child Support writs issued between January 1, 1999, to the present in Orange County; and

WHEREAS, the DOR has moved for the recall of these outstanding writs and for the denial of any pending DOR motion for contempt, due to the termination of DOR enforcement services; and

WHEREAS, the manpower required for service and execution of the writs places a tremendous burden on the Orange County Sheriff's Office and interferes with the efficient administration of justice; and

WHEREAS, the manpower required for record-keeping along with the physical housing and storage of these writs, places a tremendous burden on the Orange Clerk of Court and interferes with the efficient administration of justice; and

WHEREAS, the recalling of the active writ does not terminate a party's obligation to pay child support as required by a Final Order or Final Judgment entered by the Court; and


WHEREAS, the party owed child support, either on their own or with a private attorney, or with renewed services from the DOR Child Support Enforcement Program, may seek remedies for enforcement with the court;

NOW, THEREFORE, I, Frederick J. Lauten, pursuant to the authority vested in me as Chief Judge of the Ninth Judicial Circuit of Florida, under Florida Rule of Judicial Administration 2.215, hereby order the following, effective **immediately**, to continue until further order and superseding any provisions in prior Administrative Orders which may be inconsistent:

The Orange County Clerk of Court shall recall all outstanding active Department of Revenue Child Support writs issued between January 1, 1999, to the present. The outstanding writs are specifically listed and attached hereto as "Attachment A."

THEREFORE, IT IS ORDERED that all outstanding Department of Revenue Child Support writs issued between January 1, 1999, to the present are hereby **RECALLED AND QUASHED**; and outstanding motions for contempt filed by the Department of Revenue on the cases set forth in "Attachment A" are **DENIED**.
