

If both the Judge to whom the action is assigned and the Judge's alternate are unavailable, the matter shall be presented to the Administrative Judge of that Division. If the Administrative Judge of that Division is not available to hear the matter, it shall be presented to the Chief Judge. Emergency matters are governed by the Administrative Order No. 07-84-11.
